



## Marine Notice No. 30 of 2021

*Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers, Yachtsmen and Seafarers*

### Deployment one Wave buoy and one ADCP frame off the East Coast of Ireland, near to Wicklow

#### 1. Notice of Activity.

The Department of Transport has been advised that Codling Wind Park Limited intend to deploy metocean equipment consisting of one wave buoy and one ADCP frame, which will be used to characterise the wind park area. Weather permitting the deployment will take place between 11 May - 28 May 2021. The buoys will be in place for 12 months.

#### 2. Location of Activity

The Codling Wind Park is a project on the Codling bank approximately 13km off the East Coast of Ireland, near to Wicklow.

The wave buoy and ADCP frame will be deployed at the following location.

Wave buoy characteristics Flash Yellow (5) 20 seconds. The light is visible for up to 3 nautical miles.

A map detailing the exact location coordinates for the deployment of the metocean equipment is available in Appendix 1.

#### 3. Details of Vessel

The **AMS Retriever** (Callsign: **MEHI8**) will deploy the metocean equipment. Deployment operations will be conducted on a 12-hour basis. The vessel will be restricted in her ability to manoeuvre. All such, vessels operating within this area are requested to keep their distance, maintaining a safety zone around the deployment vessel, and pass at minimum speed to reduce vessel wash.

#### 4. Safety precautions

Throughout survey operations, the vessel will be displaying the appropriate lights and shapes as required under the COLREGS Rule 27(b).


