*Notice to all Shipowners, Fishing Vessel Owners, Agents, Shipmasters, Skippers, Fishers,  
Yachtsmen and Seafarers*

### South Irish Sea Offshore Wind Farm - Geophysical Site Investigation

#### 1. Notice of Activity

The Department of Transport has been advised that Ocean Infinity will undertake a Geophysical site survey campaign in the Southern Irish Sea between **14 July 2022** and **30 August 2022** approximately. The work will be conducted during 24 hr operations. However, please note the start date and the duration of the activity are weather dependent.

#### 2. Location of Activity

The operations will take place at the locations indicated below. Further information on the locations is available in the map at Appendices 1.

#### 3. Details of the Survey Vessel

The work will be conducted by the **Northern Maria** (call sign **OZAV2**). The survey work will be performed by a hull mounted multibeam sonar and sub bottom profiler, along with a towed side scan sonar and piggy backed magnetometer-up (tow max 320 m), and ultra-high resolution survey equipment. The vessel will conduct 24-hr operations (weather dependent). During operations, the vessel will be restricted in its ability to manoeuvre and will display the appropriate day shapes and lights. All vessels operating within this area are requested to keep their distance and pass at minimum speed to reduce vessel wash.
